

2010 Bow and Arrow Deer Hunt Instructions and Checklist

1. Property owner must complete the Release and Indemnity Agreement form indicating owner will allow hunting on owner's personal property. Property owner will indicate on the form how the deer have become a nuisance on the property and provide this form to the Orono City Hall. (The City of Orono does not allow deer hunting unless the deer have become a nuisance.) Attached to this form, the owners must provide a map of the property including the address and number of acres to the property being hunted. This map can be obtained from the Hennepin County website at: <http://www16.co.hennepin.mn.us/pins/>
[Key in address and click view map, click enter website, print & print map]
[Note: All local libraries have computers that can be used by the public]
2. Property owner must have a **minimum of five (5) acres. Two adjoining properties may be combined to make up the five acres**, but permission forms must be filled out by all property owners.
3. The number of permits given out on a property will be decided by the property owner.
4. All hunting must be done from a stand that is at least four (4) feet in elevation.
5. The hunter must have the appropriate DNR license. (**Include a copy with application.**)
6. The hunter must have appropriate **DNR license and the city permit** on his person at all times while hunting.
7. Hunter must abide by all DNR rules and regulations.
8. The hunter, in tracking animals, must have permission from any landowner before retrieving deer.
9. Permit may be revoked at any time for cause.
10. **NO HUNTING WITHIN 100 FEET OF THE LUCE LINE TRAIL, OTHER PUBLIC TRAIL OR ANY PUBLIC PARK LAND.**

**PROPERTY OWNER
RELEASE AND INDEMNITY AGREEMENT**

WHEREAS, the undersigned has voluntarily elected to allow hunting on his property in the City of Orono, County of Hennepin; and

WHEREAS, the undersigned desires to allow hunting at their own risk and recognizing the possible and inherent danger to their person and property resulting from anticipated or unanticipated cause; and

WHEREAS, the City of Orono and its contracting cities, agents and employees do not wish to be liable for any damages arising from death, personal injuries or property damage sustained;

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the undersigned does hereby, for themselves, their spouse, relatives, heirs, executor, administrator, personal representatives or other persons having interest;

- (a.) Assume full responsibility for regulating the number of hunters on their property to whom they have given permission to hunt.
- (b.) Fully and forever release and discharge the City of Orono, its agents and employees, for any and all claims, demands, damages, rights of action or causes to action, present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of the granting of permission for hunters to be on their property with a permit from the City of Orono.
- (c.) Indemnify and hold harmless the City of Orono, their agents and employees, for any acts or conduct of the undersigned of whatever kind of nature.
- (d.) Agree to defend and to pay any costs or attorney's fees as a result of any action brought by or against the City of Orono, its agents or employees, for any acts or conduct of the undersigned of whatever kind of nature whatsoever as a result of giving permission for hunters to hunt on their property with a permit from the City of Orono.
- (e.) Agree that it is the intent of the undersigned that this Release and Indemnity Agreement be in full force and effect at any time after the execution thereof while allowing hunters on his/her property.
- (f.) Agree that liability insurance for damages caused by hunters on his/her property is maintained.
