## **2010 Bowfishing Instructions and Checklist**

1. The applicant must have the appropriate DNR license(s).  
(**Include a copy with application.**) A current DNR Fishing license and a current DNR Hunting license, or a combined DNR Sports license.
2. The hunter must have appropriate **DNR license(s) and the city permit** on his/her person at all times while bowfishing.
3. Fisher must abide by all DNR rules and regulations as outlined in the current year Minnesota Fishing Regulations Guide Book.
4. Permit may be revoked at any time for cause.
5. **NO BOWFISHING FROM: DOCKS, BEACHES, BRIDGES OR LANDINGS, ROADS OR HIGHWAYS, OR ON PRIVATE PROPERTY. ALL FISHING MUST BE DONE FROM BOAT ONLY.**
6. **NO FISHING WITHIN 1000 FEET OF ANY SWIMMING BEACH, OR AS INDICATED IN MINNESOTA FISHING REGULATIONS GUIDE.**
7. **FISHING FOR GAME FISH IS PROHIBITED, CHECK DNR REGULATIONS GUIDE FOR FISH ALLOWED BY BOWFISHING.**
8. This permit only gives applicant permission to bowfish from boat on bays indicated within the City Limits of Orono.
